Project Description: The California Department of Fish and Wildlife (CDFW) has amended Streambed Alteration Agreement No 1600-2020-0188, pursuant to Section 1602 of the Fish and Game Code to the project Applicant, Huttopia Six Sigma.

CDFW's amendment includes an update to the Permittee contact, removal of 3 projects, and the revision of the project description for 3 of the original projects.
