DESIGN REVIEW COMMITTEE/PLANNING COMMISSION ACTION: On September 16, 2020, the Design Review Committee reviewed the proposal and recommended approval to the Planning Commission with conditions by a 5-0 vote. On November 2, 2020, the Planning Commission reviewed the proposal and recommended approval to the City Council with conditions by a 5-0 vote.


