



NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION

PROJECT TITLE: Vaughn Next Century Learning Center Administrative, Media/Literacy & Kitchen Building Project

SUBJECT: Notice of Intent to Adopt a Mitigated Negative Declaration for the Vaughn Next Century Learning Center Administrative, Media/Literacy & Kitchen Building Project

Notice is hereby given that the Los Angeles Unified School District (LAUSD or District), as Lead Agency under the California Environmental Quality Act (CEQA), has prepared an Initial Study (IS) for the proposed Vaughn Next Century Learning Center Administrative, Media/Literacy & Kitchen Building Project (Project), pursuant to the CEQA (Public Resources Code [PRC], Division 13, Section 21000 et seq. [CEQA Statutes] and the California Code of Regulations [CCR], Title 14, Division 6, Chapter 3, Section 15000 et seq. [CEQA Guidelines]). Based on the conclusions of the IS, LAUSD determined that the proposed Project would have no significant adverse impacts on the environment after the implementation of mitigation measures and a Mitigated Negative Declaration (MND) is appropriate. The District is providing public notice in compliance with CCR Title 14, Chapter 3, Sections 15072 and 15073, as amended.

PROJECT LOCATION: 13330 Vaughn Street, San Fernando, Los Angeles County, California.

PROJECT DESCRIPTION: The Project applicant, Vaughn Next Century Learning Center, is seeking development approval from LAUSD for the construction of a new building. The proposed Project consists of the removal of the existing 2,582 square-foot, one-story administration building and replacement with a new 26,000 square-feet, two-story building that will include six learning pods (equivalent to 12 classrooms), health and administrative offices, a media/literacy center, a teacher work room, and a cooking cafeteria.
