Project Description (Proposed actions, location, and/or consequences).

The Proposed Project includes the construction of a 4,800 square foot convenience store with twenty-one (21) parking spaces. There are eight (8) Auto-MPD 's, sixteen (16) fueling positions, and two (2) truck diesel fueling islands associated with the convenience store. The auto fueling will feature unleaded gasoline and diesel fuel. The fuel will be stored in four (4) underground storage tanks, located on the southerly portion of the project site. There will be a maximum of three (3) employees on-site at all times during business hours. Proposed hours of operation consist of twenty-four (24) per day, seven (7) days per week.

Access to and from the project site is provided via three (3) ingress and egress locations into the project site; two (2) will be located along Airport Way and one (1) will be located on Wawona Avenue. The Wawona driveway access shall be full access and access from S. Airport Way will be restricted to right-in-right-out only. As a Condition of Approval, the Proposed Project will re-stripe S. Airport Way to modify turning movements along the project site frontage.
