The proposed project would involve the development of up to 42 single-family dwelling units, and on-site recreational amenities on a 5.6-acre site. Proposed entitlements include: a General Plan Amendment (GPA) to change the land use designation from Low Density Residential (LDR) to Medium Density Residential (MDR); Zone Change (ZC) from Planned Residential Development (PR3D) to Specific Plan; approval of the Amherst Specific Plan (SP); approval of a Vesting Tentative Tract Map (VTTM); Development Review Committee approval of the Precise Plan (PPR) and tree removal permit (TRP); and a lot line adjustment (LLA).
