NOTICE IS HEREBY GIVEN that the Town of Truckee Engineering Division has prepared an Initial Study/Mitigated Negative Declaration for the Truckee Springs River Front Open Space and Trail System Project.

PROJECT DESCRIPTION: The Truckee Springs River Front Open Space and Trail System Project (proposed project) is located at the west end of South River Street and connects to the west of Riverside Drive via a proposed pedestrian bridge. The proposed project would include a pedestrian bridge across the Truckee River, short extension of South River Street with a vehicle bridge to a trailhead parking lot, paved trail to the previously approved Truckee River Legacy Trail Phase 4, soft surface trails, wetland restoration and dirt road decommissioning.

ENVIRONMENTAL STATUS: Staff has prepared an Initial Study/Mitigated Negative Declaration to evaluate the potential environmental impacts associated with the proposed project. The document is now available for review on the Town's website at www.townofTruckeeSpringsOpenSpace.

Identified potential significant environmental impacts include aesthetics, air quality, biological resources, cultural resources, geology and soils, hydrology and water quality, tribal cultural resources, and noise. However, the Town has incorporated mitigation measures to reduce or eliminate the potential impacts. The Town Council will take action on adopting the Initial Study/Mitigated Negative Declaration at the **Town Council meeting at 5pm November 10th, 2020.** The public review period for the Initial Study/Mitigated Negative Declaration begins on October 2, 2020 and ends November 3, 2020.
