## NOTICE OF AVAILABILITY OF A DRAFT ENVIRONMENTAL IMPACT REPORT AND NOTICE OF PUBLIC HEARING

Pursuant to California Code of Regulations, title 14, section 15087, this is to advise that the California State Lands Commission (CSLC), as lead agency under the California Environmental Quality Act (CEQA), has completed a Draft Environmental Impact Report (EIR) for the proposed Project described below.

Stagecoach Solar Project (Project) Project Title:

Aurora Solar, LLC, subsidiary of Avangrid Renewables Applicant:

Project Location: The proposed Project area encompasses approximately 3,000

> acres of State-owned school land in the central portion of San Bernardino County, about 12 miles northwest of the unincorporated community of Lucerne Valley and 15 miles south of the City of Barstow. The Project area is located east of Interstate 15, south of Interstate 40, and about 3 miles west

of State Route 247.

Project Description: The Applicant has applied to the CSLC for lease of lands managed by the CSLC on which to construct and operate a solar generation project. The proposed Project would produce up to 200 megawatts (MW) of solar energy using photovoltaic (PV) technology. The proposed Project area encompasses approximately 3,000 acres, with PV modules and associated infrastructure to be constructed on approximately 1,950 acres. The proposed Project also includes construction of a 9.1-mile-long 220 kV generation intertie (gen-tie) transmission line to carry the electricity generated by the solar facility to the regional transmission system interconnection at the proposed 7-acre Southern California Edison Calcite Facilities, including the substation.

Potential Significant Impacts on the Environment: The Draft EIR discusses the potential for significant impacts on the environment in 18 subject areas: Aesthetics/Light and Glare, Air Quality, Biological Resources, Cultural Resources, Tribal Cultural Resources, Energy, Geology and Soils, Greenhouse Gas Emissions, Hazards and Hazardous Materials, Hydrology and Water Quality, Land Use and Planning, Noise and Vibration, Paleontological Resources, Population and Housing, Public Services, Utilities, and Service Systems, Recreation, Traffic and Transportation, and Wildfire.

The Draft EIR identifies significant and unavoidable impacts associated with the proposed Project related to: Aesthetics/Light and Glare (visual contrast and degradation of visual character or quality); Air Quality (air pollutant emissions from construction and operation); Cultural Resources (adverse effect on a historical resource); Energy (conflict with local plans); Land Use and Planning (conflict with local plans); Public Services, Utilities, and Service Systems (increase in emergency response times); Traffic and Transportation (traffic volumes affecting the circulation system and potential effect on emergency vehicle response).
