The treatment system is composed of sediment filtration, water softening, ultraviolet (UV) disinfection, point of use reverse osmosis, calcite filter for remineralization of run-off (RO) treated water, and a distribution system serving one hospitality building. On October 8, 2017, the Tubbs Fire destroyed numerous homes, properties, and transportation facilities within Napa, Sonoma, and Yuba Counties, Paradise Ridge Winery, including its water system facilities, was destroyed as a result of Tubbs Fire. In response to the disaster Governor Edmund Brown Jr. issued a Proclamation of a State of Emergency on October 9, 2017. The Project is to restore the water system facilities of the property that were destroyed as result of Tubbs Fire. The operation of the water system regularly serves at least 25 non-residential individuals (transient) during 60 or more days per year. PUBLIC AGENCY APPROVING PROJECT AND CARRYING OUT PROJECT: This is to advise that the State Water Resources Control Board (State Water Board) has determined that the Project is exempt from the California Environmental Quality Act and will issue a drinking water supply permit for the operation of the above described Project.
