The Cottles Trail Americans with Disabilities Act (ADA) Improvements and Undercrossing Project consists of ADA improvements to an existing trail and construction of a new undercrossing under State Route 120 to connect two (2) existing portions of the Cottles Trail, and provide connectivity to the Cost Less Shopping Center. The existing trail runs along State Route (SR) 120. To access the Cost Less shopping center, pedestrians and bicyclists must cross SR 120 creating a potential safety hazard. The existing trail is 0.32-mile, and the length of the undercrossing improvement are 0.06-mile. The Project does not include a significant expansion of the trail but will connect two (2) portions of an existing trail via an undercrossing along with appropriate ADA Improvements. The Project will include a negligible expansion of the of the trail to provide connectivity to alleviate public safety concerns with the existing crossing through SR 120 for access to the Cost Less Shopping Center. 


