**NOTICE IS HEREBY GIVEN THAT** the Stanislaus County Planning Commission will hold a public hearing on **Thursday**, **February 18**, **2021**, at a meeting starting at **6:00 P.M.** in the Joint Chambers, 1010 10<sup>th</sup> Street, Basement Level, Modesto, California, to consider the following:

ORDINANCE AMENDMENT APPLICATION NO. PLN2020-0105 – HEMP CULTIVATION - Request to amend Chapter 6.85 Hemp Cultivation and Chapter 21.20 - General Agriculture District (A-2), of the Stanislaus County Code. The amendment will adopt a permanent ordinance for the cultivation of hemp in the A-2 (General Agriculture) zoning district of the unincorporated areas of Stanislaus County. The permanent ordinance will set standards for hemp cultivation, registration, nuisance, revocation, and payment of fees. Chapter 21.20 is proposed to be amended to include the hemp cultivation regulations by reference.

This project is being deemed EXEMPT from the California Environmental Quality Act (CEQA) under CEQA Guidelines Section 15183, Consistency with a General Plan for which an EIR was adopted, and CEQA Guidelines Section 15061, the Common Sense exemption.

This public hearing will be held in accordance with the Governor's Stay at Home Executive Order N-33-20 and will include both in person and remote public attendance. Please note, seating capacity in the Joint Chambers for in person attendance is limited. Instructions on how to submit public comment, including how to participate remotely are provided below.
