NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION

A Mitigated Negative Declaration (MND) has been prepared by the City of Santa Ana for the Tapestry Hotel and Restaurant Project. The City of Santa Ana is the Lead Agency, pursuant to the California Environmental Quality Act (CEQA), responsible for preparation of this document.

Project Name:		Tapestry by Hilton Hotel and Restaurant Project			
Project Description:		The project would construct a new 6-story (82 feet in height), 139 room hotel and a detached 2,000 square-foot restaurant. The project would provide 142 onsite parking spaces.			
Project Location – Identify street address and cross streets or attach a map showing project site (preferably a USGS 15' or 7 1/2' topographical map identified by quadrangle name):		1580 East Warner Avenue (also known as 1570 Brookhollow Drive) on the eastern border of the City of Santa Ana between the Costa Mesa (SR-55) Freeway and South Grand Avenue, adjacent to the southbound Dyer Road freeway off-ramp in the central part of Orange County, California.

This Initial Study was undertaken for the purpose of deciding whether the project may have a significant effect on the environment. 
