## NOTICE OF PUBLIC REVIEW AND COMMENT PERIOD

PROJECT: Davenport North Cement Kiln Dust (CKD) Area Closure Project

**PROJECT DESCRIPTION:** The project is a proposal to implement the final north cement kiln dust (CKD) area closure plan at the former Davenport Cement Plant as required by the Central Coast Regional Water Quality Control Board. Requires a Coastal Development Permit, Riparian Exception, and Preliminary Grading Review for grading approximately 165,000 cubic yards of material. Project includes a Geotechnical Report Review and Biotic Report Review.

**PROJECT LOCATION:** The project is located at the former Davenport Cement Plant at 700 Highway 1, approximately 0.5 miles north of the Davenport community in northern unincorporated Santa Cruz County. Santa Cruz County is bounded on the north by San Mateo County, on the south by Monterey and San Benito Counties, on the east by Santa Clara County, and on the south and west by the Monterey Bay and the Pacific Ocean.
