The project site is located on the south side of Elkhorn Avenue, approximately 6,691-feet west of its intersection with Cornelia Avenue, approximately 3.94 miles east of the nearest the unincorporated community of Burrel. (SUP. DIST. 4) (APN: N/A).

8. Description of project:

The project would replace a badly damaged double concrete arch culvert with a bridge that meets current safety standards. Type selection is still in progress; however, it is anticipated that the replacement bridge would be a reinforced concrete double box culvert with two 12-foot lanes. Road approach improvements would start at approximately 400 feet on either side of the bridge.

9. Surrounding land uses and setting: Briefly describe the project's surroundings:

All the Surrounding uses are agricultural operations

Pursuant to Assembly Bill (AB) 52, project information was routed to the Picayune Rancheria of the Chukchansi Indians, Dumna Wo Wah Tribal Government, Table Mountain Rancheria and Santa Rosa Rancheria Tachi Yokut Tribe offering them an opportunity to consult under Public Resources Code (PRC) Section 21080.3(b) with a 30-day window to formally respond to the County letter. No tribe requested consultation, resulting in no further action on the part of the County.
