

WHAT IS BEING PLANNED?

Location: La Vina Middle School.

The California Department of Transportation (Caltrans) proposes to improve a segment on State Route 99 from a 4-lane highway to a 6-lane highway and rehabilitate the existing lanes. The project begins in Kern County in the City of Delano at post mile 56.4 and ends at post mile 13.5, approximately 0.2 mile north of Avenue 100 (Court Avenue) in the community of Pixley in Tulare County.

WHY THIS PUBLIC NOTICE? Caltrans has studied the effects this project may have on the environment. Our studies show it will significantly affect the quality of the environment. The report that explains why is called an Environmental

Impact Report/Environmental Assessment. This notice is to inform you of the completion of the Draft

Environmental Impact Report/Environmental Assessment and of its availability for you to read and comment on. A 45-day public review period will begin on March 24, 2023, and end on May 8, 2023.

During this period, an open house will be held to give you an opportunity to discuss the project with Caltrans' staff before the final design is selected. Project-level conformity analysis shows that the project

will conform to the State Implementation Plan, including localized impact analysis with interagency consultation for particulate matter (Particulate Matter 10 and Particulate Matter 2.5) required by 40 Code of Federal Regulations Sections 93.116 and 93.123. This project is not considered a Project of Concern regarding particulate matter (Particulate Matter 10 and Particulate Matter 2.5) as defined in 40 Code of Federal Regulations Section 93.123(b)(1). A detailed Particulate Matter 10 and Particulate Matter 2.5

hot-spot analysis was not completed because Clean Air Act and 40 Code of Federal Regulations Section 93.116 requirements are met without an explicit hot-spot analysis. The project comes from a conforming Regional Transportation Plan and Transportation Improvement Program. Comment is requested regarding the project-level conformity analysis. Please submit comments for the Draft Environmental Impact Report/Environmental Assessment or the project-level conformity analysis by May 8, 2023. WHAT'S AVAILABLE?
