Project Description: The Peninsula Corridor Joint Powers Board (JPB), which operates the San Francisco Bay Area's Caltrain passenger rail service, proposes the Guadalupe River Bridge Replacement Project in the City of San José, Santa Clara County, California. Caltrain operates on two bridges over the Guadalupe River, the 1935 MT-1 bridge and 1990 MT-2 bridge, each carrying a single track. The purpose of the project is to address the structural deficiencies of the MT-1 bridge and the geomorphic instability of the Guadalupe River channel in the vicinity of the MT-1 and MT-2 bridges to provide for long-term public safety and service reliability. The major elements of the project include replacement of the 1935 MT-1 bridge with a new 265-foot pre-cast concrete structure, extending the southern end of the MT-2 bridge by 90 feet, and widening the river channel to reduce the risk of scour and bank failure issues during storm events. Project construction will take place in a series of stages to maintain existing rail services, and is estimated to take approximately two years. Construction is anticipated to begin in Spring 2022 and end in Summer 2024.

Mitigated Negative Declaration: In accordance with the California Environmental Quality Act (CEQA) and the CEQA guidelines, the JBP prepared a Draft Initial Study/ Mitigated Negative Declaration (IS/MND) for the Guadalupe River Bridge Replacement Project. Project Description: The Peninsula Corridor Joint Powers Board (IPB), which operates the San Francisco Bay Area's Caltrain passenger rail service, proposes the Guadalupe River Bridge Replacement Project in the City of San José, Santa Clara County, California. Caltrain operates on two bridges over the Guadalupe River, the 1935 MT-1 bridge and 1990 MT-2 bridge, each carrying a single track. The purpose of the project is to address the structural deficiencies of the MT-1 bridge and the geomorphic instability of the Guadalupe River channel in the vicinity of the MT-1 and MT-2 bridges to provide for long-term public safety and service reliability. The major elements of the project include replacement of the 1935 MT-1 bridge with a new 265-foot pre-cast concrete structure, extending the southern end of the MT-2 bridge by 90 feet, and widening the river channel to reduce the risk of scour and bank failure issues during storm events. Project construction will take place in a series of stages to maintain existing rail services, and is estimated to take approximately two years. Construction is anticipated to begin in Spring 2022 and end in Summer 2024.

Mitigated Negative Declaration: In accordance with the California Environmental Quality Act (CEQA) and the CEQA guidelines, the JBP prepared a Draft Initial Study/ Mitigated Negative Declaration (IS/MND) for the Guadalupe River Bridge Replacement Project. Based on the Initial Study, staff determined that the project will not have a significant impact on the environment with implementation of mitigation measures as noted in the Draft IS/MND.

ESA, Ariz. -- Arizonans eligible for the Deferred Action for Childhood Arrivals, or DACA, program are hopeful but cautious over a court ruling that could reverse a Trump administration policy that crippled the program.

A federal judge last week declared the appointment of Chad Wolf as interim Secretary of Homeland Security was unlawful, and he lacked authority when he limited access to work permits for thousands of so-called Dreamers.

Reyna Montoya is founder and CEO of the group Aliento Arizona and said the ruling could allow thousands of Arizonans to move on with their lives.

"This would allow us to hopefully reinstate the whole DACA program and all those 27,000 Arizona Dreamers who couldn't apply for the DACA program will have an opportunity to apply for it," Montoya said. "It would bring it back to the way that it was."

The case affects a total of 650,000 people brought into the United States as children by parents who were undocumented. Montoya warns Dreamers to be patient, since the outcome of the ruling could be delayed by an appeal.

Montoya added Arizona's Dreamers are cautiously optimistic that a Democratic administration will be moving into the White House in January. She said Dreamers are reminding President-elect Joe Biden of his promise to reverse President Donald Trump's executive orders aimed at DACA.


But, she said ultimately, Biden needs to get a measure through Congress to ensure the Dreamers' future.

"So is he going to work in a bipartisan manner to ensure that we have a congressional action? Because at the end of the day, we need some permanence," Montoya said.

"And if he doesn't solve it, then we might have another president in four years again who might not like the program."

Wolf was nominated for the DHS job last summer but was never confirmed by the Senate. The New York federal judge upheld a General Accounting Office finding that Wolf does not have the statutory authority to serve as acting secretary, and his order cutting DACA work permits was invalid.

ESA, Ariz. - Los arizonenses elegibles para el programa de Acción Diferida para los Llegados en la Infancia, o DACA, tienen esperanzas pero son cautelosos ante un fallo judicial que podría revertir una política de la administración Trump que paralizó el programa.

Un juez federal declaró la semana pasada que el nombramiento de Chad Wolf como secretario interino de Seguridad Nacional era ilegal, y carecía de autoridad cuando limitó el acceso a permisos de trabajo para miles de los llamados Dreamers.

Reyna Montoya es fundadora y directora general del grupo Aliento Arizona y dijo que el fallo podría permitir que miles de arizonenses sigan adelante con sus vidas.

"Esto nos permitiría restablecer todo el programa DACA y todos esos 27,000 Arizona Dreamers que no pudieron solicitar el programa DACA tendrán la oportunidad de solicitarlo", dijo Montoya. "Lo devolvería a la forma en que era".

El caso afecta a un total de 650.000 personas traídas a Estados Unidos cuando eran niños por padres indocumentados. Montoya advierte a los Dreamers que tengan paciencia, ya que una apelación podría retrasar el resultado del fallo.

Montoya agregó que los Dreamers de Arizona son cautelosamente optimistas de que una administración demócrata se mudará a la Casa Blanca en enero. Ella dijo que los Dreamers le recuerdan al presidente electo Joe Biden su promesa de revertir las órdenes ejecutivas del presidente Donald Trump dirigidas a DACA.

Pero, dijo en última instancia, Biden necesita obtener una medida en el Congreso para garantizar el futuro de los Dreamers.

"Entonces, ¿va a trabajar de manera bipartidista para asegurar que tengamos una acción en el Congreso? Porque al final del día, necesitamos algo de permanencia", dijo Montoya. "Y si no lo resuelve, entonces podríamos tener otro presidente en cuatro años de nuevo al que no le gustará el programa".

Wolf fue nominado para el puesto en el DHS el verano pasado, pero el Senado nunca lo confirmó. El juez federal de Nueva York confirmó una conclusión de la Oficina de Contabilidad General de que Wolf no tiene la autoridad legal para desempeñarse como secretario interino, y su orden de recortar los permisos de trabajo de DACA no era válida.
