Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement number 1600-2019-0310-R3, pursuant to section 1602 of the Fish and Game Code to the project Applicant, San Mateo County Department of Public Works. The Project includes stabilization of an eroding bluff that experienced extensive erosion during the 2015/2016 and 2016/2017 rainy seasons. Over the course of two phases, the County will install a shotcrete wall supported by tie back anchors and rock slope protection and replace the bridge over the Arroyo de en Medio with a new aluminum bridge.
