Caltrans proposes an AC Overlay Project on State Route 192 in Santa Barbara County from Post Mile 17.4 to 21.1. Work includes removal of 0.2' of the existing asphaltic concrete and replacing 0.2 of rubberized hot mix asphalt-gap graded within the existing roadway structure. Shoulder backing will be performed within tree feet of the edge of pavement throughout the project limits where existing shoulder backing has been degraded or is missing.
