A Director's Order was issued to replace the curb and gutter at 6998 West Lake Boulevard near PM 27.4 on Route 89 in El Dorado County. The scope of work includes removal of existing concrete curb and gutter, installation of modified curb and gutter, curb transition, traffic control and incidental work. This project is needed to avoid the failure or threat of failure to the transportation system and to prevent or mitigate the loss or impairment of life, health, property, and essential public services. Staging occurred within the Caltrans right-of-way. No excavation disposal or borrow sites needed. No consultation or coordination required. No permits required.
