A Director's Order was issued to repair damaged structural elements at the County Road 35 Overcrossing (Bridge No. 11 0062) on Interstate 5 (I-5) in Glenn County at PM 15.91. A hay truck traveling northbound on I-5 hit the Overcrossing. The scope of work includes removal and recast of damaged girder, repair damaged bridge deck, barrier rail, abutment, and wingwall, traffic control, and incidental work. This project is needed to avoid the failure or threat of failure to the transportation system and to prevent or mitigate the loss or impairment of life, health, property, and essential public services. Staging and work occurred within the Caltrans right-of-way. No excavation disposal or borrow sites needed. No consultation or coordination required. No permits required.
