## NOTICE OF AVAILABILITY OF A DRAFT EIR FOR PUBLIC REVIEW

Placer County has released a Draft Environmental Impact Report (EIR) for the project listed below:

PROPOSED PROJECT: The Ridge Subdivision (PLN19-00307), State Clearinghouse No. 2020120544

PUBLIC REVIEW AND COMMENT PERIOD: October 20, 2021 to December 3, 2021

**PROJECT LOCATION:** The project site consists of a horseshoe-shaped parcel located approximately one mile southeast of the intersection of State Route (SR) 193 and Clark Tunnel Road in unincorporated Placer County, California. The site is identified by Placer County Assessor's Parcel Number (APN) 031-106-030-000.

**PROJECT DESCRIPTION:** The proposed project would include subdivision of the project site to develop 34 single-family residential homes and associated improvements. The proposed project would require approval of a General Plan Amendment (GPA), Rezone, and a Vesting Tentative Subdivision Map. The project also requires annexation into Placer County Sewer Maintenance District 1 (SMD 1) for sewer service and approval of a Design Exception Request.

**SIGNIFICANT ENVIRONMENTAL EFFECTS:** The Draft EIR identified potentially significant project impacts with respect to Aesthetics, Biological Resources, Transportation and Circulation, and Wildfire. All potentially significant adverse impacts would be mitigable to less-than-significant levels except Transportation and Circulation related to VMT.

**PUBLIC MEETINGS:** A public meeting will be held during the public review period to receive comments on the Draft EIR. The Planning Commission Hearing Room will be open to in-person attendance.
