**Project Title:** Old Durham Wood Expansion (Lake and Streambed Alteration Agreement EPIMS Notification No. BUT-20660-R2)

**Project Location (include county):** The Old Durham Wood Expansion project (Project) is located at unnamed tributaries to Hamlin Slough, in the County of Butte, State of California; 156 Oroville-Chico Highway, Durham, California, Assessor's Parcel Number 040-120-036.

**Project Description:** The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement EPIMS Notification Number BUT-20660-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Old Durham Wood Inc. (Permittee) represented by Tim Merrill.

The Project involves the expansion of the Old Durham Wood facility and will be broken into two phases. Phase I will occur first and includes expanding the existing facility by an additional 64 acres. Phase II will include installing an access road on the perimeter of the stormwater retention area to the east. Phase I will include a full buildout of the site and will permanently impact 0.438 acres of aquatic habitat.
