Whipple Road/Industrial Parkway Southwest & Industrial Parkway West

NOTICE OF AVAILABILITY OF DRAFT ENVIRONMENTAL DOCUMENT AND ONLINE PUBLIC MEETING

The California Department of Transportation, in cooperation with the Alameda County Transportation Commission and the cities of Hayward and Union City, proposes to provide interchange and local road improvements along the Interstate 880 (I-880) from I-880/ Whipple Road-Industrial Parkway Southwest nterchange to I-880/Industrial Parkway West Interchange. This project would include interchange on-and off-ramp reconfigurations, modifications and/or replacement of bridge structures, local roadway realignments and restriping, and bicycle and pedestrian improvements to improve connectivity through the interchanges.

Due to the COVID-19 pandemic, and in an effort to protect public health, Alameda CTC will host a web-based public meeting where questions on the Draft Environmental Document (DED) may be brought forward by interested members of the public. The DED is available for review on the project website www.alamedactc.org/880WhippleIndustrial. **Please join us on Wednesday, December 2, 2020 at 5:30pm to watch a live presentation** about the project and the environmental review process, followed by an online question and answer session. A link to the virtual public meeting will be provided on the day of the event on the project website.

The Initial Study with Proposed Negative Declaration/Draft Environmental Assessment with Proposed Finding of No Significant Impact referred to in this notice complies with the requirements of NEPA and CEQA.
