Pursuant to the State of California Public Resources Code and the Guidelines for Implementation of the California Environmental Quality Act, as most recently amended, this is to advise that the City of Berkeley has prepared an Initial Study to evaluate the environmental effects of the project identified below:

Project Title: 1207 Tenth Street Mixed-Use Project

Applicant: Frederick Hyer, Hyer Architecture, 263 Amherst Avenue, Kensington, CA 94708.

Project Location: This project site is located at 1207 San Pablo Avenue in West Berkeley, midblock between Harrison Street and Gilman Street, and one block west of San Pablo Avenue.

Project Description: The project would demolish the existing buildings on the project site and construct a new, 75-foot tall, three-story, mixed-use building totaling 25,034 square feet and includes the following:

- Two live/work units totaling 3,871 square feet.
- 12 artist studios totaling 4,406 square feet.
- 2,005-square-foot research and development facility.
- 1,725-square-foot art gallery.
- 2,070-square-foot fabrication shop.
- 5,400-square-foot garage with 12 automobile parking and 24 bicycle parking spaces.
- A total of 938 square feet of useable open space.

Construction is anticipated to last approximately 24 months. The excavation depth would be a maximum of 3 feet. No pile driving would occur or be required. The project would not include an emergency generator.

Based upon the conclusions set forth in the Initial Study, the City of Berkeley proposes to adopt a Negative Declaration.
