This State funded Minor B Emergency District Director's Orders project proposes to remove and repair a section of the damaged sound wall due to a vehicle hit located at Interstate 5 (I-5) North of Main Street adjacent to Memoery Lane in City of Santa Ana, in Orange County, Post Mile (PM) 33.54 to 33.60. No Right of Way (R/W) is required; and proposed construction for this project is anticipated to begin on February 8, 2021 and complete on March 24, 2021.
