Project Description

The safety project proposes to modify traffic signals, install safety lighting, refresh pavement delineation, add signs and remove bushes to enhance visibility and improve safety at Northbound (NB) Interstate 5 (I-5) Culver/Trabuco Road on-ramp (PM R 26.6) in City of Irvine. The scope of work is summarized below:

- Remove existing signal mast arm and pole on the NB direction on Trabuco Road and install longer mast arm and pole for through and left turn lane;
- Remove existing Type 1A signal for left turn lane in the median of Trabuco Road;
- Add left turn signal head to the far-left lighting pole for the left turn lane in the NB direction of Trabuco Road and add right signal head for the right turn lane in the SB direction of Trabuco Road;
- Remove existing signal mast arm and pole on the SB direction on Trabuco Road and install longer mast arm and pole with two signal heads on the mast arm for through direction;
- Upgrade existing pedestrian push button and pedestrian signal head to APS and ped signal head LED countdown;
- Install two additional safety lights at the NB on-ramp;
- Add and refresh pavement delineation and signing;
- Remove blocking bushes at the ramp entrance to enhance visibility;
- Add two R-89 signs below signal heads at the NB on-ramp;
- Replace chevron signs to meet retro-reflectibility standards

The project is eligible for both federal and state funding. The state funding will be from the 2020 State Highway Operation and Protection Program (SHOPP), under the Safety Improvement Program. The project is scheduled for construction in Fiscal Year (FY) 2021/2022.

Purpose: The purpose of this project is to minimize the number and severity of collisions by enhancing the overall visibility at this location. Visibility will be enhanced by modifying the existing traffic signals, providing additional safety lighting, adding new signs, removing bushes, and refreshing pavement delineation.

Need: NB I-5 on-ramp at Culver Drive/Trabuco Road is experiencing a higher concentration of collisions than average for similar facilities.
