Oakport Security Gate

Project Description

The purpose of this project is to design and install a bi-fold security gate at the EBMUD Oakport Storage Center at 5601 Oakport Street in Oakland, California.

Justification

The access road to the EBMUD yards at the Oakport Storage Center does not have an access gate. The lack of an access gate and adequate security measures has contributed to multiple thefts at the Oakport Storage Center. The gate will also serve to protect the City of Oakland's sports fields, which are accessible to the public only by reservation. The gate will be operated jointly with the City of Oakland, in order to provide approved access while also protecting property.

Permits

Any required permits will be acquired from the City of Oakland by the Facilities Engineering Section.

Schedule

Design and installation of the security gate is anticipated to be completed by December 2021.

Operational Impact

The project will be designed and scheduled to minimize impacts to the operation of the Oakport Storage Center.

Public Impact

This project will not affect the general public. This work will be performed entirely on District property. Access will be granted to members of the public that have secured appropriate reservations for use of the sports fields from the City of Oakland.

EBMUD Practices and Procedures

Standard construction environmental and safety practices applicable to all EBMUD construction projects have been incorporated into the Project. These standard practices minimize impacts to the public resulting from EBMUD construction projects.
