ABC Unified School District proposes to install two solar energy arrays on elevated carport-like structures (Structures A and B) at Furgeson Elementary School. Structure A would be located over a grass field north of the kindergarten playground toward the center of the campus, and Structure B would be located over asphalt courts to the northeast of Structure A between the playfield and the school building. Structures A and B would be a minimum of 10-foot high and comprised of metal columns and beams supporting array panels. Structure A would consist of 231 photo-voltaic (PV) modules tilted at a 7-degrees angle, and Structure B would consist of 162 PV modules tilted at 7 degrees angle. The solar system would have the combined direct current (DC) system size of 165.060 kilowatts (kW), 97.020 kW for Structure A and 68.040 kW for Structure B. The structures would connect to an existing electrical equipment box in the surface parking lot in the front of the campus by installing approximately 434 feet of underground conduit through directional boring that would pass through asphalt court and concrete paving. The project would also provide underground conduit for installation of car chargers in the future. However, Installation of car chargers require additional funding and would not be installed at this time. The District and general community will benefit from a reduction in energy consumption and reduced energy costs.

The proposed project was also reviewed for possible exceptions under Section 15300.2 and found that the exceptions do not apply.
