DRAFT SUPPLEMENTAL ENVIRONMENTAL IMPACT REPORT

PERMANENTE CREEK RESTORATION PLAN

As the Lead Agency, the County of Santa Clara ("County") has prepared a Draft Supplemental Environmental Impact Report (Draft SEIR) for the project described below:

Hanson Permanente Cement, Inc., and the Lehigh Southwest Cement Company (collectively "Lehigh") submitted a Grading Approval application for the Permanente Creek Restoration Project (the "Project") to restore and modify approximately 9,000 linear feet of Permanente Creek (135.6 acres) in accordance with the provisions of the Amended Consent Decree between the Sierra Club and Lehigh, dated May 11, 2016. The Project is located in an unincorporated area of the County west of the City of Cupertino, between 2 and 3 miles west of the intersection of Interstate 280 and Highway 85 in the eastern foothills of the Santa Cruz Mountain. The Project is within the Permanente Creek watershed along the southern edge of Lehigh's property both within and outside of the existing reclamation plan boundary of the Lehigh Permanente Quarry. The creek restoration requirements of an Amended Consent Decree reflect restoration duties imposed on Lehigh that originally stem from San Francisco Regional Water Quality Control Board Cleanup and Abatement Order No. 99-018. The Draft SEIR is a supplement to the Lehigh Permanente Quarry Reclamation Plan Amendment Draft EIR [SCH #2010042063] that the County prepared and certified in 2012 ("2012 EIR").

The SEIR evaluates whether the Project would cause one or more new significant impacts or a substantial increase in the severity of a significant impact than was disclosed in the 2012 EIR. The Project has the potential to result in new impacts, or a substantial increase in the severity or previously identified impacts, to biological resources. With the implementation of a new mitigation measure for California red-legged frog (*Rana draytonii*) and a replacement mitigation measure for roosting bats, the SEIR concludes that the Project's impacts would be mitigated to a less-than-significant level.
