# **Project Description**

The California Department of Transportation (Caltrans) issued a Director's Order to repair a sinkhole on State Route 49 near PM 46.30 in Sierra County. Field investigation by Caltrans maintenance crew concluded that a culvert underneath the roadway had failed due to accumulated sediment partially blocking the outlet, creating a 9-foot or larger void beneath the roadway. The scope of work is as follows: replacing failed culvert, clearing and grubbing near outlet, regrading downstream ditch line, traffic control, and incidental work. The impacts of this sinkhole necessitate immediate repairs. This problem must be arrested prior to next winter season in order to avoid the failure of travel way. This project is needed to avoid failure or threat of failure to the transportation system, which can result in the loss or impairment of life, health, property. All work occurred within Caltrans right-of-way. No disposal that required a borrow site. No consultation or coordination required. No permits required.
