

CITY OF SANTA CRUZ Notice of Intent to Adopt a Mitigated Negative Declaration

The Administrator of Environmental Quality of the City of Santa Cruz is preparing to issue a Mitigated Negative Declaration of environmental impact for the following proposed project:

Project: Mentel Aerial Sewer Improvement ProjectApplication No.:CP21-0065Project Location: 158 Forest Avenue (APN 011-042-29), 202 Forest Avenue (APN 011-042-03), 105Mentel Avenue (APN 011-221-06), 101 Mentel Avenue (APN 011-101-12) in the City of Santa Cruz.

Project Description: The proposed project consists of a Coastal Development Permit for construction of an approximate 304-linear foot 8-inch sewer line that would be parallel to and replace an existing 6-inch sewer pipeline. The new sewer line includes 130 linear feet of aerial construction and 174 linear feet of underground construction. The new sewer line will be installed in the same alignment as the existing pipeline at a distance of approximately 18 inches from the existing sewer line.

Significant Effects on the Environment: Hydrology and Water Quality

The Administrator of Environmental Quality of the City of Santa Cruz has reviewed the proposed project and has determined that the project, with mitigation measures as conditions of project approval, will not have a significant effect on the environment.
