Caltrans proposes a highway maintenance project that overlays Route 115 at two locations with Asphalt Rubber (AR) Chip Seal to preserve the life of existing AC pavement. All work will be within Caltrans right-of-way and the existing pavement limits, except for some routine shoulder backing (0'-3' from edge of pavement), as needed at various locations, fog sealing or replacing of the existing AC dikes. The project is located in Imperial County near Holtville from 0.1 mile south of Route 8/115 Separation to Towland Road, and from Junction Evan Hewes Highway to Junction Route 78/115.
