
Notice of Intent to Adopt a Mitigated Negative Declaration and Announcement of Virtual Public Meeting

(Study Results Available)

State Route 183 Castroville Improvement Project



WHAT IS BEING PLANNED?

The California Department of Transportation (Caltrans) proposes to rehabilitate the pavement on State Route 183 (Merritt Street), through cold planing and asphalt overlay, to improve the ride quality and prevent further deterioration. The project will include maintenance work on the State Route 183/State Route 156 Separation Bridge. The project would improve accessibility under the Americans with Disabilities Act to address deficiencies within the project limits where feasible. Existing sidewalks would be reconstructed to improve access. New sidewalk features and crosswalks would be constructed to improve access and connectivity for pedestrians. The project would construct new public transit facilities and modify existing public transit facilities to improve access and connectivity for public transit users. A Class 2 Bikeway (bike lane) would be delineated at select locations to improve access and connectivity for bicycle users. Roadway striping would be adjusted to improve vehicle operations and traffic movement through the project limits. Existing traffic detection and traffic monitoring systems would be upgraded to improve real time traffic information. The project will require new right-of-way in order to widen Merritt Street and construct improvements to roadway and multimodal access.

WHY THIS PUBLIC NOTICE?

Caltrans has studied the effects this project may have on the environment. Our studies show it will not significantly affect the quality of the environment. The report that explains why is called an Initial Study with Proposed Mitigated Negative Declaration/Environmental Assessment. This notice is to tell you of the preparation of the Initial Study with Proposed Mitigated Negative Declaration/Environmental Assessment and of its availability for you to read and to notify you of the virtual public meeting.
