Project Location (include county): The project is located at the section of Cache Creek known as "Huff's Corner", a reach on the south bank extending approximately 2,700 feet upstream from the Interstate 5 (I-5) crossing, in the County of Yolo, State of California; Latitude 38.722082°, Longitude -121.808254°; Assessor's Parcel Numbers 025-310-044-000 and 025-310-025-000.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement EPIMS Notification Number YOL-13602-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, the County of Yolo.

The project consists of restoring an existing 2,700-foot-long reach of levee to its original design profile and reconfiguring a segment of the Cache Creek channel to address ongoing erosion of the south bank.
