**Description of Project:** The project consists of The Metropolitan Water District of Southern California (Metropolitan) entering into an agreement for water delivery with Department of Water Resources (DWR). Between April 1, 2021 and March 31, 2022, up to 100,000 acre-feet of water would be delivered from Diamond Valley Lake to Mills Water Treatment Plant using the agencies' existing water conveyance and distribution systems (e.g., Inland Feeder, Lakeview Pipeline, Perris Bypass, Box Springs Feeder, Santa Ana Valley Pipeline, Reach 28H Turnout, Box Springs Feeder). No construction is anticipated or required for the water deliveries.

Deliver MWD water from Diamond Valley Lake to MWD's Mills Treatment Plant via DWR's Santa Ana Valley Pipeline

**Purpose**: Helps Metropolitan preserve SWP storage in carryover, which can be delivered to all parts of Metropolitan's service area and helps maximize SWP storage going into 2022.

Amount: Up to 100,000 acre-feet.

Timeframe: 04/01/21-03/31/22

**Operations**: Flow of water would be from Diamond Valley Lake to the Inland Feeder to the Lakeview Pipeline (via interconnection) to the Perris Bypass Pipeline to DWR's Santa Ana Valley Pipeline to the Box Springs Feeder turnout to Mills Treatment Plant.
