# Description of Nature, Purpose, and Beneficiaries of Project:

The project goal is to reconnect Colby Creek, Willow Creek West, and Snag Lake to their natural floodplains. Restoration of the natural hydrologic function will enhance groundwater recharge, attenuation and delay of peak flows, and improve late season stream flow. Meadow restoration will include constructing Post-Assisted Log Structures and Beaver Dam Analogs, treating headcut features, providing riffle augmentation, filling artificial channel/ditch features, lowering roads and removing culverts, constructing multiple grade control structures by felling large trees, and removing encroaching lodgepole pine trees. The project will restore 215 acres of wetland and 29,586 linear feet of stream channel.
