Project Location (include county): The project is located at an unnamed tributary to Markham Ravine and associated wetlands, in the County of Placer, State of California. The project site is approximately centered on Latitude 38.895667, Longitude -121.311056 (WGS 84 datum, decimal degrees).

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement EPIMS Notification Number PLA-24423-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Joiner Limited Partnership.

The proposed project is a residential subdivision consisting of 198 single-family medium-density residential lots. The project is limited to mass grading for building pads, roads, utilities, associated infrastructure, and minor offsite improvements. The project includes construction of a stormwater collection system where all runoff from the site will be routed to water quality swales before ultimately draining to the unnamed tributary along the southern project site boundary line.
