Project Description (Proposed actions, location, and/or consequences).

The applicant seeks approval of a Development Plan with a 20% density bonus to allow the construction of a new apartment complex on an approximately 3.81-acre lot. Designed as family housing, the project proposes approximately 15 one-bedroom units, 15 two-bedroom units, 36 three-bedroom units, and 34 four-bedroom units in one building consisting of three- and four-story elements (maximum height 45 feet). Vehicular access is provided around three sides of the building with surface parking at the ground floor. Site access is consolidated through a driveway on the eastern side of the property. The building creates an interior, outdoor courtyard featuring a play area, community gardens, seating areas, and community room access for residents. Site improvements include an onsite dog park, one monument sign, bioretention basins, a perimeter fence, sidewalk, curb, roadway, and gutter improvements along the southern edge of the project site to +/-700 feet east, exterior lighting, and +/-5,000 net total cubic yards of grading. +/-2,500 linear feet of water main extension within the right-of-way is also proposed. The project consists of a lot merger of the two parcels. No code-protected trees will be altered or removed as part of the project.

Identify the project's significant or potentially significant effects and briefly describe any proposed mitigation measures that would reduce or avoid that effect.

Aesthetics: mitigations include installation of landscaping, shielding/pointing down exterior lighting, use of non-reflective finishes to minimize glare. Air Quality: Bay Area Air Quality Management District Basic Construction mitigation measures during construction would reduce temporary impacts from, e.g., dust, loose materials, and idling trucks/equipment. Biological Resources: mitigations include requiring pre-construction avian surveys by a qualified biologist and providing buffers around nesting/roosting sites, delaying construction until the end of nesting or blooming periods, erosion/sediment control for minimization of direct effects to watercourses. Cultural Resources: if prehistoric/historical materials or human remains are encountered during construction activities, mitigations include stopping work & qualified archaeologist or the County Coroner to examine the site/materials. Hydrology: mitigations include prohibiting any drainage, debris, or construction equipment entering the Contra Costa Canal and coordinating trenching activities with the Contra Costa Water District. Geology/Soils: mitigations include submittal of a design-level geotechnical report for review by County Geologist, observation/testing/report by project geotechnical engineer during construction activities and prior to final inspection. Noise: mitigations for temporary noise due to construction activities include a pre-construction meeting with inspectors/contractor, notifying neighbors within 300 feet prior to grading/construction, limiting the hours of construction and heavy equipment usage and requiring all internal combustion engines to be fitted with mufflers. Population/Housing: mitigating the need for additional child care includes submittal of a child care proposal for one or a combination of methods, including but not limited to payment of an in-lieu child care fee per unit.

Issues were were raised by the Contra Costa Water District (CCWD) during the public review period for the project's Initial Study/Mitigated Negative Declaration (IS/MND). CCWD identified concerns about drainage, debris, and construction equipment entering the adjacent Contra Costa Canal or impacts on the CCWD's existing 42-inch multi-purpose pipeline due to any construction activities, including trenching for the proposed water main extension, and installation of the pipeline extension on the bridges crossing the Canal. Their concerns were addressed in the IS/MND revised for recirculation on November 22, 2021, including new mitigations HYD-1 through HYD-3.
