# NOTICE OF INTENT TO ADOPT A <u>MITIGATED</u> NEGATIVE DECLARATION MONTEREY COUNTY <u>PLANNING COMMISSION</u>

NOTICE IS HEREBY GIVEN that Monterey County Housing & Community Development has prepared a draft Mitigated Negative Declaration, pursuant to the requirements of CEQA, for a Use Permit (Smith Richard C & Susan Boone Smith Trs [Eco-Site], File Number PLN170647), located at 8515 Coker Road, Salinas (Assessor's Parcel Number 125-102-001-000); see description below.

The project does not involve the burning of municipal wastes, hazardous waste, or refuse-derived fuel or is on a list enumerated under Section 65962.5 of the Government Code. (Additional Noticing Requirements if the project does involve these products.)

The <u>Planning Commission</u> will consider this proposal at a meeting on July 28, 2021 at 9 a.m. in the Monterey County Board of Supervisors Chambers, 168 West Alisal, 2<sup>nd</sup> Floor, Salinas, California. Written comments on this Mitigated Negative Declaration will be accepted from June 4, 2021 to July 6, 2021. Comments can also be made during the public hearing.

**Project Description:** Use Permit to allow a new wireless communication facility consisting of a 65 foot tall mono-Oak with at-ground equipment shelter and fence enclosure. The property is located at 8515 Coker Road, Salinas (Assessor's Parcel Number 125-102-001-000), North County Area Plan.
