DESCRIPTION OF THE NATURE AND PURPOSE OF PROJECT: The project proposes to provide accessibility upgrades at Manchester State Park to improve access for park visitors and to bring facilities in compliance with California State Parks accessibility guidelines and associated legal mandates. Work will:

In the Campground:

At each campsite #7, #8 and #24 (possibly #12):

- Excavate to install a concrete parking stall, and timber-edged, compacted aggregate tent pad and picnic area with ADA-compliant fire pit;
- Excavate to install timber-edged, compact aggregate access paths from the campground road to the new parking spaces;
- Excavate to install concrete paths of travel to two (2) existing CXT buildings;
- Remove two (2) non-compliant water stations near the campsites and replace with two (2) ADA-compliant water stations;
- Excavate to install a timber-edged, compacted aggregate path of travel to the existing campfire center and around the fire pit and screen; and
- Develop one (1) accessible seating area with bench and companion seating space.

At the Group Camp:

- Excavate to install three (3) timber-edged, compacted aggregate, tent sites as well as 5' wide accessible paths connecting tent sites to a new accessible picnic area;
- Excavate to install timber-edged, compacted aggregate surfaces and install three (3) accessible picnic table, one (1) accessible preparation table, one (1) accessible fire pit;
- Relocate two (2) existing non-accessible picnic tables;
- Excavate to pour a new, 20' x 16; concrete parking stall with access aisle and a 5' wide concrete pathway to the restroom;
- Install four (4) new animal proof trash receptacles; and
- Excavate to pour a 5' x 5' concrete pad and install one (1) accessible water station/drinking fountain.

In the Day-Use and at Trailhead:

- Construct one (1) new concrete parking stall with access aisle next to the existing CXT building;
- Excavate to install a 5' wide concrete path of travel to the CXT and two (2) new 12' x 16' accessible picnic site pads;
- Install log barriers between the new accessible picnic sites and the roadway; and
- Excavate to install two (2) concrete pads for two (2) relocated informational panels and interpretive signs.
