# DESCRIPTION OF THE NATURE AND PURPOSE OF PROJECT:

This project is a rehabilitation of the historic Dingley Spice Mill Building located in Old Sacramento State Historic Park. The Dingley is the only remaining original building on this portion of "I" Street in Old Sacramento and was last rehabilitated in 1975.

The project will consist of:

- Clean mortar off brick faces, repair and repoint all loose or failing brick and repoint all mortar joints on East and North exterior walls;
- Repair all window frames, windowsills, sashes, re-glaze all sashes with new glass as necessary;
- Repair and repaint all metal window shutters;
- Repair all building hardware;
- Repair loose anchors in brick;
- Repair all interior and exterior doors and door hardware;
- Repaint all previously painted building surfaces;
- Recoat entire existing roof, roof flashing and seal all roof penetrations with high quality roof repair coating
- Repaint all previously painted building surfaces;
- Install remanufactured signage with updated hardware, and;
- Prime and paint interior back stairwell, windows and doors; re-carpet back stairwell and replace all second-floor interior windowsills.
