A zoning amendment to change the current zoning designation to Resource Conservation (RC) from Rural Living (RL), as well as four (4) Conditional Use Permits (CUPs) to develop the Lockhart Solar PV II Project (Project), a utility scale, solar photovoltaic (PV) electricity generation and energy storage facility that would produce up to 150 megawatts (MW) of solar power and include up to 4 gigawatt hours (GWh) of energy storage capacity rate in a battery energy storage system (BESS) within an approximately 755-acre Project Site.
