# WHAT IS PLANNED


The California Department of Transportation (Caltrans) is proposing to replace the existing Elk Creek Bridge (Caltrans Bridge #10-0120), on State Route 1 at post mile 31.5, just south of the Community of Elk, California. The proposed project would improve the function of the Elk Creek bridge by providing 12-foot lanes, 4-foot shoulders, and a separated pedestrian walkway on the west side of the bridge.
