Project Location, Specific: Work will occur on the left side (L) of the California Aqueduct (Aqueduct) right of way (ROW) at milepost (MP) 167.43. The worksite is located approximately 500 feet southeast of the intersection of the Aqueduct and Plymouth Avenue in Kings County.

Description of Nature, Purpose, and Beneficiaries of Project: Westlands Water District (WWD) has requested permission to encroach in the Department of Water Resources' (DWR) ROW to excavate a 10-foot-wide by 10-foot-long by 4-foot-deep area at MP 167.43L. WWD will first remove a protective concrete cylinder and will then excavate approximately 15 cubic yards of soil; the soil will be stockpiled next to the excavated area. Then, a 5-foot section of vertical PVC pipe that ties into the subline will be removed to access the air release valve. The valve will be inspected and will either be repaired or replaced using hand tools, and the vertical PVC pipe will be replaced with galvanized pipe. The area will be backfilled and compacted, and the protective concrete cylinder will be installed in its original location. WWD Contractors will benefit.
