Barrel Springs Road Resurfacing

Barrel Springs Road, within the City of Palmdale, from the southerly prolongation of 32nd Street East (City of Palmdale boundary) to the pavement line south of the intersection of 25th Street East and Pearblossom Highway, representing approx. 114,000 cumulative square feet of pavement within existing City right-of-way

Description of Nature, Purpose and Beneficiaries of Project: The nature of this project is general street maintenance in the form of street resurfacing, including a cold mill of the existing pavement, installation of an asphalt concrete leveling course, and installation of an asphalt rubber hot mix overlay. The purpose of this project is to provide a new driving surface on Barrel Springs Road, within the existing edges of pavement (no widening), to improve the condition of the road by eliminating surface cracks and other imperfections, provide a smoother driving surface, and to extend the useful life of the existing road section. Existing dirt shoulders will be shoulder backed for driver safety. No existing trees or vegetation outside of the right-of-way will be removed or disturbed with the construction activity. Beneficiaries of the project will be vehicle operators, bicyclists, pedestrians, and owners of the properties fronting the improved streets.
