The Los Angeles County ("County") Department of Regional Planning, acting in the capacity of "Lead Agency" under the County Environmental Guidelines, Chapter III, Section 304, has prepared an Initial Study – Mitigated Negative Declaration (IS-MND) for the Project in accordance with, and pursuant to, the California Environmental Quality Act (CEQA), as amended; Public Resources Code, Section 21000 et seq.; and the "Guidelines for Implementation of the California Environmental Quality Act (State CEQA Guidelines), California Code of Regulation, Title 14, Chapter 15000 et seq., (including Sections 15162 and 15164).

#### **PUBLIC REVIEW PERIOD**

The formal public review period for the IS-MND will be from <u>July 21, 2021 to August 20, 2021</u> (30 days). All comments received by the closing of the public review period will be considered by the Regional Planning Commission at a later-scheduled public hearing as described below.

#### SITE LOCATION

Southwest intersection of West Avenue A and 90th Street West, Antelope Acres

## PROPOSED PROJECT

The applicant, AES, requests a conditional use permit (CUP) to authorize the construction, operation, and maintenance of a 21-megawatt utility-scale photovoltaic ground-mounted solar energy facility ("solar facility") on approximately 145 acres of a site in the A-2-2 (Heavy Agricultural – Two Acre Minimum Required Lot Area) Zone. Also proposed on site is a 28-megawatt electric battery storage system. Proposed grading totals approximately 71,550 cubic yards to be balanced on site. Perimeter fencing and landscaping as required by the County Code will be installed. Solar panels will be mounted on a single-axis tracking system.
