The existing structure is a Historic County Landmark structure that will remain in place. The project will occur on county owned Right-of – Way, located at 9600 block of Geysers Rd., Cloverdale, **Supervisorial District 4.**

In accordance with Public Resource Code and CEQA Guidelines, the County of Sonoma provides notice to agencies and interested parties that it is releasing a final Initial Study and Mitigated Negative Declaration (IS/MND) for the project.
