The proposed Trash Net will be installed within an existing channel upstream of a cross drainage culvert located off SR 99 at Zeff Road, in the city of Modesto. The trash net will consist of two flanking overflow weirs on either side of the pipe and will be anchored to a concrete pad 6" thick. A disposable trash net will be attached to the end of the pipe to capture the trash particles from being discharged to the water body. All project work will be within Caltrans' right of way. The Trash Net will be used to capture trash from stormwater runoff from the adjacent freeway before it discharges into the nearby lower Tuolumne River. The project is located within a significant trash generating area along this segment of SR 99. The installation of the Trash Net will bring Caltrans in compliance with the trash provisions as identified in the statewide trash implementation plan. The proposed project will improve the water quality objectives as identified in the statewide trash control provisions.

Environmental Provisions:

General

The project is Categorically Exempt under the California Environmental Quality Act (CEQA) and Categorically Excluded under the National Environmental Policy Act (NEPA) unless: (1) The scope of the project changes to include additional activities or areas; or (2) There is unforeseen discovery of sensitive or cultural resources. Environmental reevaluation will be required if any one of 1 and 2 occurs.

<u>Air</u>

The project is exempt from all project-level conformity requirement per Table 2 of 40 CFR 93.126 under the project type "Shoulder Improvements". The Transportation Air Quality Conformity Checklist was completed February 10, 2021. The following Caltrans Standard Specifications will require the contractor to comply with the air pollution control rules, ordinances, and regulations and statues:

AQ 1- Caltrans Standard Specifications Section 14-9.02, Air Pollution Control

AQ 2- Caltrans Standard Specifications Section 10-5, Dust Control

Biology

Per the project scope, the proposed project will have "no effect" on any special status habitats or vegetation communities considered for environmental review. The project will require the disturbance of urban or ruderal vegetation but is not expected to result in the loss of mature trees or shrubs. No Clean Water Act Section 404 permit or Section 401 Certification is required. No California Fish and Game Code Section 1600 Agreement is required. No consultation under the federal Endangered Species Act or California Endangered Species Act is required.

Measures would be implemented to prevent the "take" (as defined by California Fish and Game Code Section 86 or defined by the Federal Endangered Species Act (FESA) Section 3) of FESA or California Endangered Species Act (CESA) listed species, California Species of concern, California Fully Protected Species, California "rare" plant species, plant species protected by the California Native Plant Protection Act, or CNDDB tracked species or habitats.

The above Caltrans Standard Specifications will be implemented to define protective Environmental Study Area (ESA) distances for certain bird species as per below:

- If an active raptor is observed, a 300-foot ESA will be implemented around the nest until the young have fledged or a qualified biologist determines that construction may proceed.
- If an active Swainson's hawk nest is observed, a 600-foot ESA buffer will be implemented around the nest until the young have fledged or a qualified biologist determines that construction may proceed.

Pre-construction surveys and/or biological monitoring for nesting migratory birds or raptors, or other sensitive species would be required if construction activities occur during the migratory bird nesting season (February 1 to September 30). Because the environmental study limit is relatively small and because a relatively small number of working days (90 working days or less) is expected, it is suggested that a Department-supplied biologist would be responsible for any pre-construction surveys and/or construction monitoring for sensitive biological resources. No long-term, post construction survey, monitoring, or mitigation effort is expected or required.

Cultural

The project has a determination under Section 106 of the National Historic Preservation Act of *No Historic Properties Affected*. The proposed project will not directly or indirectly affect any known archaeological resources. Therefore, the proposed project is exempt from further cultural review.

Executive order 12898 (Environmental Justice)

No minority or low-income populations would be adversely affected by the proposed project have been identified in the project area. There is a mobile home park community, *Sunny Village Mobile Home and RV Park*, adjacent to the project area that would be considered an Environmental Justice population under Executive Order 12898. Considering the scope and nature of the proposed project work, there would be no affect or impact to this community; Therefore, this project is not subject to the provisions of Executive Order 12898.

<u>Floodplains</u>

The project is located within a 100-year base floodplain and will not result in a significant encroachment in the 100-year floodplain.

Hazardous Waste

There is a potential to encounter non-hazardous concentrations of Aerially Deposited Lead (ADL) while working in unpaved areas adjacent to the highway. There is a potential to encounter ADL impacted soil during project construction. A project specific ADL soil survey shall be conducted prior to construction activities. A preliminary site investigation (PSI) will be conducted in the Plans, Specifications, and Estimates (PS&E) phase of the project and additional SSPs may be added based on results of the PSI.

Noise

The project will have no adverse noise impacts; however, during construction, the project should comply with Caltrans Standard Specifications regarding construction noise.

NQ 1- Caltrans Standard Provision 14-8.02, Noise Control, which states construction noise resulting from work activities should not exceed 86 Dba at 50 feet from the job site from 9:00 pm to 6:00 am.

NQ 2- All equipment will have sound-control devices that are no less effective than those provided on the original equipment.

Water

The project will have no adverse effect on Water Quality. In order to eliminate or minimize any potential impacts to the environment, the following measures will be implemented:

- If the project disturbs one acre or more of soil:
 - A Notification of Intent (NOI) is to be submitted to the appropriate Regional Water Quality Control Board at least 30 days before the start of construction.
 - A Stormwater Pollution Prevention Plan (SWPPP) is to be prepared and implemented during construction to the satisfaction of the Resident Engineer.
 - 3. A Notice of Termination (NOT) shall be submitted to the Regional Board upon completion of construction and site stabilization. A project will be considered complete when the criteria for the final stabilization in the Construction General Permit are met.
