

NOTICE OF AVAILABILITY OF A DRAFT ENVIRONMENTAL IMPACT REPORT (EIR) AND ENVIRONMENTAL ASSESSMENT (EA) AND NOTICE OF PUBLIC MEETING FOR THE HOPPER SLOUGH BRIDGE REPLACEMENT PROJECT



The California Department of Transportation (Caltrans), the Lead Agency for the California Environmental Quality Act (CEQA) and for the National Environmental Policy Act (NEPA), is issuing a Notice of Availability (NOA) of the Draft Environmental Impact Report (EIR) and Environmental Assessment (EA) to solicit public and agency input on the project and the environmental issues addressed in the EIR/EA.

WHAT IS BEING PLANNED?

The California Department of Transportation (Caltrans) proposes to replace the Hopper Slough Bridge located in the town of Rutherford in Napa County on State Route 128 a half-mile east of State Route 29. Replacement of the bridge would ensure continued operation of the highway for all its users.

WHY THIS AD?

Caltrans has studied the proposed project and has determined that there would be significant impacts to biological and visual resources as a result of the project. The Draft EIR/EA explains why the project would have significant impacts to environmental resources. This public notice is to inform you of the Draft EIR/EA's availability for review during a 45-day public comment period.
