A PUBLIC HEARING HAS BEEN SCHEDULED BEFORE THE PLANNING COMMISSION OF THE CITY OF FONTANA TO RECEIVE COMMENTS ON THE DRAFT ENVIRONMENTAL IMPACT REPORT (DEIR) (NO FORMAL ACTION WILL BE TAKEN) ON THE FOLLOWING PROJECT:

## Master Case No. 21-064 & Design Review (DRP) No. 21-025

The proposed Project is the development of a two-building industrial commerce center containing a total of 355,370 square feet and associated facilities, including but not limited to a loading/unloading area with loading dock doors and trailer parking spaces, passenger vehicle parking, landscaping, and connections to existing utility infrastructure. The proposed buildings are intended to be used as industrial commerce facilities; however, the end users have not been identified at this time. Therefore, specific details about the future operation of the proposed buildings are not currently available, but given the possibility that operations at the Project Site may occur twenty-four (24) hours a day and seven (7) days a week, the environmental analysis has assumed this level of activity.

The Project Site is located immediately south of Interstate 10 (I-10), north of the intersection of Slover Avenue and Business Drive, east of Commerce Way, and approximately 0.1-mile west of Mulberry Avenue. The approximately 18.5-acre Project Site encompasses two individual parcels, Assessor Parcel Numbers (APNs): 0238-062-36 and 0238-062-39. The Project Site is not included on any list of hazardous materials sites compiled pursuant to California Government Code Section 65962.5.

<u>Project Impacts:</u> The Draft Environmental Impact Report evaluates the Project's potential individual- and cumulative-level environmental impacts on the following resource areas: aesthetics, agriculture and forestry resources, air quality, biological resources, cultural resources, energy, geology and soils, greenhouse gas emissions, hazards and hazardous materials, hydrology and water quality, land use and planning, mineral resources, noise, population and housing, public services, recreation, transportation, tribal cultural resources, utilities and services systems, and wildfire. The Draft EIR indicates that, after the application of identified mitigation, the Project would not result in a significant impact to the environment (i.e., all Project-related impacts would be less than significant).

<u>Public Comments:</u> A public hearing with the Fontana Planning Commission has been scheduled for July 19, 2022, at 6:00 p.m. The hearing will take place in-person at the City's Council Chambers located at 8353 Sierra Avenue, Fontana, CA 92335. The proposed project will be addressed and considered at a subsequent and currently unscheduled meeting/hearing to be held by the Fontana Planning Commission.
