

WHAT IS BEING PLANNED?

The California Department of Transportation (Caltrans) proposes to construct a roundabout at the intersection of State Route 190 and Rockford Road, between post miles 11.31 and 11.51 in Tulare County.

WHY THIS PUBLIC NOTICE?

Caltrans has studied the effects this project may have on the environment. Our studies show the project will not significantly affect the quality of the environment. This notice is to inform the public that an Initial Study with Proposed Negative Declaration has been prepared for the project and is now available for review and comments. This notice also offers the opportunity to request a public hearing.
